Directions

Going South on I-25

Take Exit 211 (23rd/20th Avenue)
Go south on the Frontage Road
Turn right on 20th Avenue
Drive one block west to TUCC on your right

Going North on I-25

Take Exit 210C (17th Avenue)
Turn right at stop sign (Bryant Street)
Turn left on 20th Avenue
Drive one block west to TUCC on your right

From the Wheat Ridge, Northwest Denver area

Take 38th Avenue east to Federal Boulevard south
Turn left on 20th Ave.
Turn left on Mile High Stadium Circle
Drive one block east to TUCC on your left

From Central Denver

Take Speer Boulevard North
Turn left on 29th Avenue
Turn left on Federal Boulevard
Turn left on 20th Avenue
Turn left on Mile High Stadium Circle
Drive one block east to TUCC on your left

From Lakewood

Take US-6 East (6th Avenue)
Go north on Federal Boulevard
Turn right on 20th Avenue
Turn left on Mile High Stadium Circle
Drive one block east to TUCC on your left
